

SUMMARY ANNUAL REPORT

This is a summary of the annual report for the Evergreen Teachers Association Health & Welfare Trust Fund (Employer Identification No. 77-6019718, Plan No. 501), for the plan year beginning September 1, 2021 and ending August 31, 2022. The annual report has been filed with the Employee Benefits Security Administration, U. S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

The following brief description of the plan benefits is provided for general information purposes only. Participants should refer to the plan document for more complete information.

SELF-FUNDED BENEFIT INFORMATION

The Plan maintains its disability and long-term care benefits under a self-funded program. The Plan reimburses a portion of premiums for non-Kaiser coverage participants. Total premium reimbursements and long-term care benefits paid by the trust were \$351,420.

INSURANCE INFORMATION

The Plan has a contract with Kaiser Foundation Health Plan for medical and Unum Life Insurance Company of America for life insurance and accidental death and dismemberment. The total premium expense for the plan year ending August 31, 2022 was \$1,006,189.

BASIC FINANCIAL STATEMENT

The value of the plan assets after subtracting liabilities of the Plan was \$8,579,321 as of August 31, 2022 compared to \$10,469,560 as of September 1, 2021. During the plan year, the Plan experienced a decrease in its net assets of \$1,890,239. The Plan had total loss of (\$391,644), including employer contributions of \$618,672, participant contributions of \$465,784, loss from investments of (\$1,476,100). Plan expenses were \$1,498,595. These expenses included \$351,420 incurred for the benefit of participants and beneficiaries, \$1,006,189 in premiums expense for participants and beneficiaries and \$140,986 in total operating expenses. A total of 864 persons were participants in or beneficiaries of the Plan at the end of the plan year.
